Accreditation of programmes

The re- submission documentation for accreditation of your BEng and MSc programmes was discussed at the Joint Board of Moderators (JBM) meeting, held on the 7th October, 2016.

I am writing to advise you that following this Board meeting, the member institutions of the Joint Board of Moderators (the Institution of Civil Engineers, the Institution of Structural Engineers, the Chartered Institution of Highways and Transportation and the Institute of Highway Engineers) have approved the recommendations below:

Recommendation is in regard to a CEng accredited bachelor degree.

It is recommended that the programmes listed below be accredited by ICE, IStructE, IHE and CIHT as part satisfying the academic base for a Chartered Engineer, and as fully satisfying the academic base for an Incorporated Engineer, under the provisions of UK-SPEC for the intakes **2014 - 2018**. Graduates from these programmes will be required to complete approved CEng Further Learning to satisfy the academic base requirement for a Chartered Engineer:

BEng Civil Engineering (4 years full-time including Level 0) [awarded by Xi'an Jiaotong-Liverpool University]

BEng (Hons) Civil Engineering (4 years full-time including Level 0) [awarded by University of Liverpool]

As the JBM visiting team was also able to view the work of recent graduates during the visit, it is also recommended that accreditation be backdated to cover the intake period 2010 – 2014.

Recommendation is in regard to a CEng accredited bachelor degree.

It is recommended that the programmes listed below be accredited by ICE, IStructE, IHE and CIHT as part satisfying the academic base for a Chartered Engineer, and as fully satisfying the academic base for an Incorporated Engineer, under the provisions of UK-SPEC for the intakes **2014 - 2018**. Graduates from this programme will be

required to complete approved CEng Further Learning to satisfy the academic base requirement for a Chartered Engineer:

BEng Civil Engineering (Specialisation: Architectural Engineering) (4 years full-time including Level 0) [awarded by Xi'an Jiaotong-Liverpool University]

BEng (Hons) Architectural Engineering (4 years full-time including Level 0) [awarded by University of Liverpool]

Recommendation is in regard to programmes submitted for Further Learning for a Chartered Engineer (Technical)

It is recommended that the programme listed below be accredited by ICE, IStructE, IHE and CIHT as meeting the requirements for Further Learning for a Chartered Engineer (CEng) under the provisions of UK-SPEC for intakes **2014 - 2018** for candidates that have already acquired a CEng accredited BEng(Hons) undergraduate first degree:

MSc Sustainable Construction (Technical) (1.5 years full-time, 3 years part-time)

It is recommended that the programme listed below be accredited by ICE, IStructE, IHE and CIHT as meeting the requirements for Further Learning for a Chartered Engineer (CEng) under the provisions of UK-SPEC for intakes **2016 - 2018** for candidates that have already acquired a CEng accredited BEng(Hons) undergraduate first degree:

MSc Civil Engineering (Technical) (1.5 years full-time, 3 years part-time)

A paper submission of output including coursework and dissertations will need to be made of work from the first graduating cohort in approx. summer 2018 and it will be possible to link this review to the next re-accreditation visit.
