The BSc Economics and Finance programme will provide you with a real competitive edge as you gain knowledge of both economic and financial theory and an understanding of the relation between the mechanisms driving economic systems and the workings of capital markets.

You will develop the intellectual, analytical and modelling skills needed to solve problems in economics, finance and related areas. You will also learn to use the analytical tools required to appreciate and critically analyze economic and financial policy issues and problems.

The interdisciplinary path will prepare you for specialist courses such as financial economics and financial econometrics. The programme will provide a basic knowledge of accounting, which is invaluable for understanding how enterprises work.

The programme is delivered in the International Business School Suzhou (IBSS), one of an elite group of institutions worldwide to be accredited by the Association to Advance Collegiate Schools of Business (AACSB), European Quality Improvement System (EQUIS) and Association of MBAs (AMBA). IBSS was the youngest business school to achieve the triple accreditations.

By the time you graduate from the BSc Economics and Finance programme, you will have:

- a solid background in economic and financial theory
- a good understanding of these two fields and the ability to build on this interdisciplinary perspective to solve contemporary market questions

- the ability to apply the knowledge and skills required to solve specific theoretical and applied problems in economics and finance
- preparation for the job market, with a sound understanding of economics in general and a specialised knowledge of financial markets.
