MSc PROFESSIONAL ACCOUNTING

The MSc Professional Accounting programme has a strong focus on professional training, equipping you with the skills and knowledge to succeed in an international business career.

You will study the professional syllabus of the Institute of Chartered Accountants in England and Wales (ICAEW) and will obtain exemptions from all six professional-level papers of the exams needed to gain chartered accountant status (subject to validation of the programme by ICAEW), as well as receiving preparation to sit the final advanced-level papers.

The programme is delivered in the International Business School Suzhou (IBSS), one of an elite group of institutions worldwide to be accredited by the Association to Advance Collegiate Schools of Business (AACSB), European Quality Improvement System (EQUIS) and Association of MBAs (AMBA). IBSS was the youngest business school to achieve the triple accreditations.

By the time you graduate from the MSc Professional Accounting, you will have:

- theoretical understandings appropriate to the study of accounting at postgraduate level
- an awareness of key current issues, theory and practice in the field of accounting
- skills in professional accounting and financial decision-making, evaluation and analysis of financial data and the techniques required to evaluate and act upon complex financial and tax-related issues encountered in practice
- the knowledge necessary towards qualifying and operating as a chartered accountant

本硕士专业会计课程专注于专业培训, 为学生提 供专业会计所需的技能和知识, 以便在国际商务领 域中获得一席之地。

通过本专业学习, 学生将有可能获得英格兰及威尔 士特许会计师协会 (ICAEW) 的英国皇家特许会 计师 ACA (Associate Chartered Accountant) 专业阶段科目的免试资格(须通过专业评审),并可 参加 ACA 的高级阶段科目的考试。在通过考试并 从事相关工作三年后, 学生将有机会获得英国皇家 特许会计师资格证书。

西浦国际商学院已于 2016 年和 2018 年分别获得 国际高等商学院协会 AACSB (Association to Advance Collegiate Schools of Business) 和 欧洲质量发展体系 EQUIS (European Quality Improvement System) 认证, 并于 2020 年获 得英国工商管理硕士协会 AMBA (The Association of MBAs)认证。这标志着西浦国 际商学院成为全球第103所,也是最年轻的一所获 得商学院三大顶尖认证的国际一流商学院。
